# GOLF SEASON TICKET



## Terms and Conditions

1. Your season ticket card must be shown prior to obtaining your golf round ticket.
2. Golf round tickets must be retained throughout play, and produced on request in conjunction with your season ticket card.
3. Failure to give notice of cancellation prior to tee-off time will result in full payment being required.
4. Round tickets are valid for the day and time of issue only.
5. Commencement of play must be as per your allocated time of booking. Late arrival may result in play not being available.
6. Replacement of a lost season ticket card will incur the holder a £5.00 fee. No entry will be permitted without the production of a valid season ticket card.
7. Season ticket cards are non-transferable. Tickets issued to season ticket holders are non-transferable.
8. No refunds will be given.
9. Annual season tickets – will run for a period of 12 months. Regrettably no refunds can be given if you terminate your season ticket before the expiry date.
10. Season tickets paid by Direct Debit – will run for a period of 10 months, with first payment due on joining, followed by 9 monthly payments. Non-payment of a direct debit will automatically render your season ticket as invalid, and legal action will commence for recovery for any outstanding sum.
11. Defaulting on Direct Debit payment will effect the ability for us to enter into future credit agreements.
12. Normal rules and regulations of the course will apply (these are available for you to see in the golf shop).
13. Access to the course and its facilities will be as per the operating times displayed in the golf shop.
14. Queen's Park Golf Course reserves the right to amend or cancel any golf play due to circumstances beyond our control. No compensation for whatever reason will be given.
15. Queen's Park Golf Course reserves the right to close any of the facilities in the event of an emergency, essential maintenance, essential refurbishment or development works or major events. There is no financial compensation for members in these circumstances.
16. Single players are allowed to play at the discretion of the Golf Play organiser, but have no standing on the course. Where possible, the golf play organiser will arrange a playing partner.
17. Restricted tee time available on Sundays from opening to last tee time at 11.58am.
18. All tee times are subject to availability and must be pre-booked.
19. Queen's Park Golf Course reserve the right to refuse any bookings and rescind season tickets.
20. Buggy policy - Queen's Park Safety policy acceptance form must be completed before play.

### The Direct Debit Guarantee

All Direct Debit payments will be deducted from your bank/building society on the 2nd day of each month (should this fall on a bank holiday, the payment date will be taken on the preceding day).

This guarantee is offered by all banks and building societies that take part in the Direct Debit scheme. The efficiency and security of the Scheme is monitored and protected by your own bank or building society.

If the amounts to be paid or the payment dates change, you will be told of this in advance by at least one month.
